Total attending: 35 signed in.

Introduction: OGCS President Karen Marzocco welcomed all to the AGM. Karen noted that OGCS by-law requirements had been met: providing at least 15 days notice to members of the AGM date and having a quorum of at least 3 members. Copies of the Agenda, Draft Minutes of the February 28, 2018 AGM, Financial Report, Directors' Report and Proposed Constitution and Bylaws were available at the back of the room. Only members in good standing were eligible to vote, holding up yellow voting cards provided during registration. Current OGCS Directors were introduced and thanked for their support. Non-voting Board member Corinne Ambor, DWV Manager of Parks Planning and Community Stewardship, was thanked for her dedication and guidance to OGCS Directors. Advisory Members David Cook and Terry Taylor and representatives of other stewardship groups were recognized and thanked for their community work: WVSS, LPPS and FCPP.

- 1. Approval of AGM Agenda: Motion to approve agenda: moved by Katharine Steig, seconded by David Cook, carried unanimously by show of voting cards.
- **2.** Adoption of Minutes of March 8, 2017 AGM: Motion to adopt minutes: moved by Katharine Steig, seconded by Alan Bardsley, carried unanimously.
- 3. Treasurer's Report: Copies of the Statement of Financial Position and Income Statement as at January 31, 2019 were provided by Doug Bardsley. OGCS's current bank balance is \$2,735.80, an improvement of almost \$1,000 over 2018. OGCS currently has 50 members in good standing. Donations were \$1.035 this year. OGCS expenses were higher due to a return to travel/honorariums for speakers and minor costs for the BCIT OGC survey. OGCS also has a stewardship role for the Black Creek Environmental Fund held by the West Vancouver Community Foundation and standing at \$18,397.27 at June 30, 2018. Nothing has been spent from this Fund since its inception in 2013. Motion to accept the Treasurer's Report: made by Herb Storm, seconded by Paul Hundal, carried unanimously.
